

Legislative Update

WE ARE BEING HEARD IN HARRISBURG!

According to Winston Churchill, "Americans will always do the right thing, only after they have tried everything else." At PASR we hope that this sentiment holds true for the Pennsylvania General Assembly in regards to a Cost Of Living Adjustment (COLA) for PSERS annuitants because we know that they have done everything except grant a COLA for over 20 years!

PASR's ideal COLA legislation would be to provide a 25% increase to all pre Act 9 retirees to erase the 25% deficit that Act 9 created in their pensions compared to those who retired after Act 9 went into effect, AND an annual COLA for everyone every year that is tied to a measure of inflation. At the moment, this goal is purely aspirational because the PA General Assembly has refused to act to provide any type of COLA and has shown reluctance to pass a smaller COLA for pre Act 9 retirees only. Alas, we endeavor onwards and act to secure as much of this goal as possible as the political realities of the day will allow.

PASR, through the communications of its members with their legislators, has achieved two victories in the fight for a COLA. First, The PA House of Representatives passed House Bill (HB) 1416...further than any other COLA legislation in the past 20+ years! We owe Representative Deasy and Malagari our thanks for championing these bills. This bill would grant pre Act 9 retirees between 15-24.5%, depending on the retirement date of the annuitant. A companion bill has been introduced in the Senate by Senator Muth (Senator Kane introduced a similar bill as well) in the form of Senate bills (SB) 952. We now need the Sente to pass either HB 1416 or SB 952! Please visit our website to utilize a form letter to communicate with your Senator about your desire for them to pass a COLA this year!

The second victory has come in the form of SB 864. Senator Katie Muth was the prime sponsor of this bill, which would grant pre Act

9 retirees a COLA of between 15 and 24.5%, just like HB 1416, AND provide an automatic COLA to every PSERS annuitant every three years. Such a bill would eliminate the need to beg legislators every year for a COLA, as a COLA would be awarded automatically and be pegged to a measure of inflation. Moreover, this bill would provide a COLA to post Act 9 retirees as well as pre Act 9 retirees. It would provide limits such as a maximum increase of 7%, but, if adopted, it would be the first ever automatic COLA for PSERS annuitants! Sadly, the General Assembly seems to have little appetite for such a bill. As such, PASR is strongly urging the passage of HB 1416 and then PASR will work to secure a COLA for all annuitants, as some post Act 9 annuitants have gone over 20 years without a COLA while inflation has diminished their pension significantly.

PASR regrets the that HB 1416 would provide a COLA only to Pre Act 9 annuitants, but PASR was faced with the decision to either accept a COLA for some of those most in need or accept nothing for everyone since legislators have made it clear that any COLA for all annuitants is very unlikely to occur at this time. Consequently, PASR has reluctantly accepted that something is better than nothing and that PASR will use this potential victory as a stepping stone to securing a COLA for everyone in the future. PASR simply could not refuse to support HB 1416 and risk not securing some financial help for Pre Act 9 annuitants that are an average age of 83 and receive an average of \$18,500 per year from PSERS.

PASR knows everyone could use a COLA and we are actively working to achieve this goal. The most helpful efforts to secure any COLA are constituents relaying their desires for a COLA to their elected officials. So far, PASR members have made their voices heard! We hope that you, our members, will continue to advocate for a COLA with veraciousness! As you do so, you may wish to note that there

is a \$14 billion surplus in the state coffers and that legislators will receive another COLA in their salaries which will have given them approximately a 20% pay increase over the past three years since their salary COLA is pegged to inflation. Additionally, Act 9 increased the pension multiplier for educators from 2 to 2.5, but legislators' multiplier increased from 2 to 3, giving them a 50% increase in their own pensions.

The PA government then saw fit to not contribute fully to the pension system for eight years, which contributed greatly to the PSERS fund

going from 125% funded to being 67% funded today, yet many legislators now say they can't vote for a COLA because the PSERS fund is not fully funded!

As Churchill also said, "I never worry about action, but only inaction". With this in mind, PASR will continue fighting to secure your retirement and we hope that you will join this fight with us; please visit our website https://www.pasr.org/legislative-cola-information/ and use the available form to send a message to your state senator to urge him/her to pass COLA legislation NOW!


